# RESOLUTION NO. 02:28:23 - 2 RE: APPROVING AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONIES

BE IT RESOLVED, that the Agreement between the Town Highway Superintendent of the Town of Beekman, Dutchess County, New York and the undersigned members of the Town Board. Pursuant to the provisions of Section 284 of the Highway Law, agree that the moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. sum of \$369,865.00 shall be set aside to be expended for primary work and general repairs upon 2.88 miles "5.76 Lane Miles" out of 135.92 lane miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

2. PERMANENT IMPORVEMENTS: The following sums shall be set aside to be expended for the "permanent improvement" of Town Highways:

(a) On the road commencing at the intersection of Sterling Drive and leading up onto Gardner Hollow Rd finishing at the pavement end a distance of .68 miles, "1.36 lane miles" "4780 feet" there shall be expended not over the sum of \$113,427.50 for 1185 Tons of Blacktop Width of traveled surface 24 Feet With a Thickness of 1.5"

(b) On the road commencing at Lime Ridge Road traveling southeast on Lime Ridge Road 4850 feet ending at State Route 216, a distance of .92 miles, "1.84 lane miles" there shall be expended not over the sum of \$95,298.75 for 1000 Tons of Blacktop Width of traveled surface 24 feet with a Thickness of 1.5"

(c) On the road commencing at the intersection of Gold Road and Depot Hill Road traveling northwest on Gold Road for a distance of .46 miles "0.92 lane miles" for a total : of "2500 feet" there shall be expended not over the sum of \$58,000.00 for 620 Tons of Blacktop for a thickness of 1.5"

(d) On the road commencing at the intersection of State Route 216 and Depot Hill Road traveling East on Depot Hill Road for 4350 feet ending at the intersection of Carol Lane a distance of 0.82 miles, "1.64 lane miles", there shall be expended not over the sum of \$103,138.75 for 1080 Tons of Blacktop Width of traveled surface 22 Feet with a Thickness of 1.5"

# RE: RESOLUTION AUTHORIZING STIPULATION OF SETTLEMENT AND GENERAL RELEASE

WHEREAS, a civil proceeding seeking money damages for an alleged violation of civil rights was commenced in the United States District Court for the Southern District of New York (20-cv-09180 (VB) (PED)) against the Town of Beekman Highway Superintendent, the Town of Beekman Supervisor and the Town of Beekman; and

WHEREAS, the Town of Beekman served an Answer denying any wrongdoing and seeking dismissal of the lawsuit; and

WHEREAS, the matter was dismissed against the Town of Beekman Supervisor, leaving the Town of Beekman Highway Superintendent and the Town of Beekman as remaining parties in the action; and

WHEREAS, to avoid the costs of further litigation, the parties wish to resolve all disputes and claims asserted or which might have been asserted in the lawsuit by means of the Settlement Agreement and General Release.

NOW THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Beekman hereby authorizes a Stipulation of Settlement and General Release in full satisfaction of this matter against the remaining parties; and

BE IT FURTHER RESOLVED, that the Town Board hereby authorizes the Supervisor to sign the Stipulation of Settlement on the Town's behalf as well as any other documentation as may be necessary to effectuate the purpose and intent of this Resolution and fully settle and resolve the aforementioned pending action.

# CREDIT CARD POLICY

## PURPOSE

To establish internal controls and criteria for the use of credit cards issued to employees of the Town of Beekman for the purpose of conducting Town Business.

## II. OVERVIEW

The use of credit cards has been determined to be a convenient and cost effective method of obtaining certain products and services for the Town. The primary purpose will be to pay vendor invoices within the Finance department and will continue to follow the existing Town's purchasing policy. Additional purchasing may be conducted only when purchasing with the card will facilitate a specific advantage to the Town where payment in advance is required with only a credit card and could also include pricing or availability. Some travel and training costs may also be handled best through the credit card process.

## III. PROCEDURE

For all transactions which occur within the Finance department, the purchasing will flow through the existing procurement process. The vendor payment will be made within the Finance department once all existing procurement procedures and approvals have been completed.

For any additional purchasing the following will apply.

- A. Issuance of Credit Cards
  - Cards will be issued at the discretion of the Supervisor and will be accessible to Department Heads to be used only on an as needed basis. These individuals then become the responsible party to all supporting documentation related to all transactions placed with that card. All cards issued will carry a limit of \$2,500 and will be adjusted as necessary by the Supervisor to accommodate specific purchases upon gaining the appropriate approvals. The Finance Department shall maintain an up-todate, written list of the names, positions (titles) and credit card account numbers for all cards issued.
  - 2. As needed will be defined as to only those individuals who are regularly authorized to make purchases and where the traditional procurement process will not work. Examples of these instances would be limited to when a vendor offers items and/or services at an advantage to the Town where payment in advance is required with only a credit card and could also include pricing or availability.
  - 3. The employee must sign documentation verifying agreement to the conditions of use. A copy of which will be retained by the Finance Department.

D. Security

It is the cardholder's responsibility to immediately notify the Town of a lost or stolen card. Failure to do so will result in disciplinary actions and/or revocation.

- E. Separation
  - 1. Prior to separation from employment from the Town of Beekman, the Cardholder shall surrender the credit card held in their name if not already in the custody of the Town. It will immediately be shut down by the Supervisor.
- F. Revocation of Credit Card Privileges
  - 1. The issuance of a credit card to an employee is done at the discretion of Supervisor.
  - 2. Failure to comply with proper record keeping procedures as outlined in this policy will be cause to revoke the employee's credit card privilege.
  - 3. Repeated loss or theft of any issued credit card will be cause to revoke the Employee's credit and privilege. Failure to immediately report the theft/loss of a card upon discovery may also lead to revocation of the credit card privilege.







At the top Gardner Hollow Rd., where I live, a logging outfit is cutting down 600 acres of trees.

The forest is owned by Starkdale Farm in Dover, but they have staged their operation at the spot where Dover, Pawling, and Beekman intersect.

(The address is 623 West Dover Rd., Dover, NY. The parcel number is 132600-6958-00-690892-0000).

The DEC has told me that two threatened or endangered species live in the forest, the Indiana Bat and the Bog turtle, but the logging can occur now, when they are dormant. They will awaken to find their homes gone. Many other animals will also suffer the habitat loss.

Neighbors and I are concerned about the effect on our road in Beekman. Trees prevent erosion. Without them, sediment and water can run down the road. We also worry about sediment logging the streams that flow through Beekman and several towns and the effects on drinking water.

Residents of Beekman, and people from far and wide, have enjoyed the beauty of this forest. It has been an environmental treasure.

On February 22 I addressed the Dover Town Board about the logging. I am not sure that it understood the full impact of the tree removal.

The head of the logging firm, Mid-Hudson Forest Products, told me two days ago that the operation has gone on for a month, and it has a month to go.

I hope our town can contact Dover and ask for a halt to the cutting and a study of the full environmental impact.

The County's Division of Veterans Services ensures Dutchess County veterans and their families receive their maximum eligible benefits from the Department of Veterans Affairs and other agencies at all levels of government.
