**RE: RESOLUTION CREATING SNOW & ICE REMOVAL AND ROAD REPAIR RESERVE**  
**IN THE HIGHWAY FUND**

**WHEREAS**, the GML Section 6-F provides for the creation of a Snow/Ice Removal and Road Repair Reserve Fund by municipalities, and

**WHEREAS** the Town Board of the Town of Beekman is desirous of creating this Reserve in the Highway Fund to pay the excessive cost of removal of snow and ice from public thoroughfares and for the cost of repairing roadways to the extent that the damage was caused by the continued removal of snow and ice provided such repairs are not recurring.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of Beekman hereby approves the creation of the "Snow/Ice Removal & Road Repair Reserve" in the Highway Fund in the amount of \$100,000 pursuant to GML 6-F as of fiscal year end December 31, 2021 to be funded from the Unrestricted Fund Balance in the Highway Fund and,

**BE IT FURTHER RESOLVED**, that the Chief Fiscal Officer is hereby directed to deposit and secure moneys for the Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Chief Fiscal Officer may invest the moneys in the Reserve Fund consistent with the investment policy of the Town of Beekman. Any Interest earned shall accrue to and become part of the Reserve Fund.

Except as otherwise provided by law expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of this governing board and such additional actions or proceedings as may be required by Section 6-F of the General Municipal Law.

**LICENSE AGREEMENT FOR IMPROVEMENTS TO TOWN CENTER PARK FIELDS**

**THIS AGREEMENT** entered into this 21 day of March, 2022 by and between

**TOWN OF BEEKMAN**

a municipal corporation with  
its offices located at 4 Main Street, Poughquag, NY 12570  
(hereinafter referred to as the "TOWN")  
and

**BEEKMAN ATHLETIC CLUB**

a Not-for-Profit Organization operating under 503s charity with  
an address of P.O. Box 364, Poughquag, NY 12570  
(hereinafter referred to as "BAC").

**WITNESSETH:**

**WHEREAS**, the Town owns and operates a recreation park commonly known as the Town Center Park ("TCP") located at 71 Town Center Boulevard, Hopewell Junction, New York, and more particularly described as Tax Map Parcel # 6759-00-584429; and

**WHEREAS**, BAC has an agreement with the Town to use TCP fields for the purpose of providing baseball and softball programs for residents of the TOWN; and

**WHEREAS**, BAC desires to make improvements to TCP fields 1, 2 and 3 at BAC's sole expense; and

**WHEREAS**, the TOWN agrees that it is in the best interest of the residents of the TOWN to allow BAC to make improvements to TCP fields 1, 2 and 3 as hereinafter set forth.

**NOW, THEREFORE**, in consideration of the mutual covenants, promises and agreement herein set forth, the parties do covenant and agree as follows:

1. **Recitations Incorporated.** The recitations above set forth are incorporated in this Agreement as if fully set forth and recited herein.
2. **Granting of License.** The TOWN hereby gives and grants to BAC, and BAC hereby accepts from the TOWN a revocable license to install a scoreboard on TCP field 1 and install foul poles on TCP fields 1, 2 and 3 as depicted in the product data sheets and engineered structure design as approved by the Town Building Inspector.
3. **Ownership/Construction.** The installation of the scoreboard and foul poles on TCP fields will be undertaken at the sole cost and expense of BAC. All improvements within TCP fields shall be at all times considered owned by the TOWN and operated and maintained by BAC, their successors and/or assigns.



4. **Compliance.** BAC shall comply strictly with the plans as approved by the Town Engineer so as to be in compliance with all applicable New York State, County of Dutchess and Town of Beekman local laws, ordinances, resolutions, codes, rules and regulations. All installations shall be at the sole cost of BAC and any improvements upon termination of this revocable license shall be transferred to the TOWN.

5. **Maintenance.** Once installed, BAC shall be responsible for all future maintenance of the scoreboard and foul poles at TCP fields.

6. **Reimbursement for Damages.** BAC agrees to reimburse the TOWN for any and all damages or injury to any real property or personal property of the TOWN that may arise, directly or indirectly, from the negligence, acts or omissions of BAC, or any of BAC's officers, agents or employees.

7. **Insurance.** BAC shall name the TOWN as additional insured on all insurance for liability and property damage and shall protect the TOWN from claims for damages for personal injury including accidental death, for property damage and specifically shall name the TOWN as additional insured on its business policy. Insurance shall be as follows:

A single limit policy in the amount of at least \$1,000,000.00 for death or bodily injury and property damage liability claims, public liability insurance, blanket contractual liability, broad form property damage liability insurance and business coverage. BAC shall furnish a copy of the above-described policies (or a certificate showing issuance thereof) to the TOWN naming the TOWN as additional insured in said policy(ies).

8. **Indemnification.** BAC agrees to defend, indemnify, and save harmless the TOWN from and against any and all law suits, claims, causes of action, cost, expenses, damages, liabilities and judgments, including reasonable attorneys' fees, (hereinafter collectively referred to as "Claims") of every name and description brought against the TOWN for or on account of any death, injuries or damage received or sustained by any party or parties by or from the negligence of BAC, or any of BAC's officers, agents, or employees arising from BAC's use of this License Agreement.

9. **Limits of Revocable License.** This revocable license granted herein:

- (a) is not a conveyance of real property;
- (b) is not intended to grant or convey to BAC the exclusive use of the land on which BAC constructs its improvements;
- (c) is granted subject to grants, conveyances, easements, and rights-of-way heretofore made to others;
- (d) is granted to the right (which the TOWN hereby reserves) of the TOWN to use and enjoy the lands within the boundaries of the property described

herein in any manner which does not unreasonably interfere with the right herein granted to BAC; and

- (e) is granted subject to the rights of the TOWN with respect to any licensing and insurance requirements applicable to BAC to use the ballfields in accordance with the Town of Beekman Department of Recreation and Parks Policies & Procedures for Use of Facilities as approved by the Town Board on January 25, 2022, and as may be amended from time to time.

10. **Assignment.** In accordance with the provisions of section 109 of the General Municipal Law BAC is hereby prohibited from assigning, transferring, conveying, subletting or otherwise disposing of this Agreement, or of its right, title or interest in this Agreement, or its power to execute this Agreement, to any other person or corporation without the previous consent in writing of the TOWN.

11. **Authority.** The Supervisor has executed this Agreement pursuant to a Resolution adopted by the Town Board of the Town of Beekman, at a meeting thereof held on May 8, 2022. Sharon Wohrman, Deputy Supervisor, whose signature appears hereafter, is duly authorized and empowered to execute this Agreement on behalf of the Town of Beekman. This Agreement shall be executed in duplicate. At least one copy shall be filed, after execution thereof, in the office of the Town Clerk of the Town of Beekman.

12. **Entire Agreement.** This Agreement constitutes the complete understanding of the parties.

13. **Modification to Agreement.** No modification of any provisions thereof shall be valid unless in writing and signed by both parties.

14. **Legal Fees.** In the event any action is commenced to enforce or interpret the terms or conditions of this Agreement, the prevailing party shall, in addition to any costs or other relief, be entitled to recover its reasonable attorneys' fees, including fees for the use of in-house counsel by a party to this Agreement.

15. **Counterparts.** This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.

16. **Binding Effect.** This Agreement shall be binding upon and insures to the benefit of the parties hereto and their respective legal representatives, successors, and assigns.

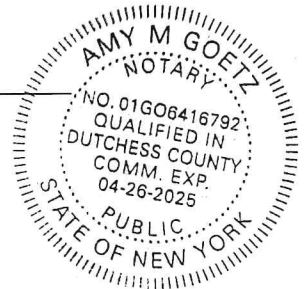

9. **Official Uniforms.** CUSTOMER agrees that the color, style embroidery and/or manufacture of the industrial uniforms ordered pursuant to or in connection with this AGREEMENT are and will remain the official uniform of the CUSTOMER, to be worn by its employees in the conduct of its business during the term of this AGREEMENT unless a change is agreed upon by the parties.

If the CUSTOMER shall fail to give written notice of termination within the ten (10) day period or otherwise notify ULSTER UNIFORM SERVICE, INC. of his or its dissatisfaction with regard to the service and/or quality of goods, it shall be conclusively presumed that ULSTER UNIFORM SERVICE, INC. has corrected the deficiencies set forth in the written complaint of the CUSTOMER.

Oil & lead based paints (**no latex!**), photo chemicals, non-latex driveway sealer, pool chemicals, creosote, kerosene, flammable liquids, metal polish, turpentine, stains, varnishes, strippers, thinners, gasoline/oil mixture, brake fluid, antifreeze, pesticides, herbicides, fungicides, chemical fertilizers, adhesives, resins, solvents, fluorescent tubes (tape together or put in box to prevent breakage), propane tanks, mercury containing devices, computer monitors, CPU's, fax machines, printers, TV's, stereos, telephones, lithium & sealed lead acid batteries (**no automotive!**).

Do Not Bring:

Waste in containers larger than 10 gallons, ammunition or explosives, asbestos products, latex driveway sealer & latex paint, building or construction debris, tires, furniture, medical waste, pharmaceuticals, air conditioners, radioactive materials, scrap metal, metal drums or empty containers, motor oil, car batteries, alkaline or rechargeable batteries.

**Latex Paint - Add kitty litter or sawdust to dry out remaining paint, and then place the can in your regular trash**

**AAA, AA, C, D, 9 Volt and lantern batteries are regular household trash**

**Rechargeable Nickel Cadmium Batteries and cell phones – Bring to a drop off location at a local retailer**

**Automotive Batteries and Motor Oil - Drop off at auto centers or local repair shop.**

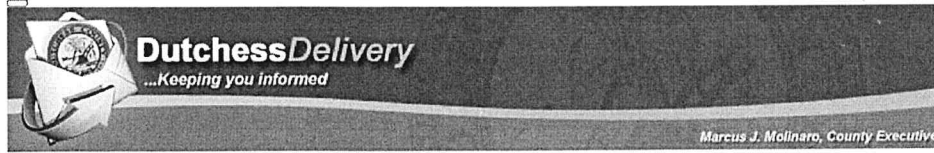

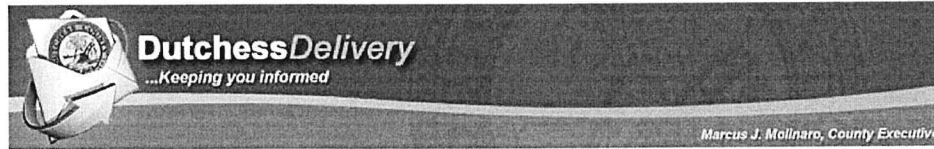

## Dutchess County Collecting Supplies to Assist Ukraine

*County partnering with Afya Foundation to collect needed donations at the former JCPenney site*

**Poughkeepsie ...** Dutchess County, in partnership with the Afya Foundation, will be hosting a humanitarian supply collection site to gather items to help those affected by the invasion in Ukraine, including wounded soldiers, civilians and refugees. Donations will be collected at the former JCPenney location (lower level) at the Poughkeepsie Galleria at 2001 South Road (Route 9) in Poughkeepsie over the next two weekends.

County Executive Marc Molinaro said, "This is a horrifying and heartbreaking time for Ukraine, and I know many people in Dutchess County are anxious to help. The generosity of our community has always been strong, and there are specific needs we can help meet. Knowing the heart of this community, let us all come together to help the people of Ukraine, donate what you can and pray for peace."

Donation collection schedule is as follows:

- Saturday, March 12th from 9am-1pm
- Friday, March 18th from 1pm-5pm
- Saturday March 19th from 9am-1pm

No appointment is necessary and Dutchess County Medical Reserve Corps (MRC) volunteers will be on hand to assist those bringing donations.

Afya has provided a specific list of needed items. Only new, unopened and non-expired goods will be accepted from the list below. No other supplies are being collected at this time. Needed supplies are as follows:

- Flashlights and Flashlight batteries
- Baby and Adult Diapers
- First Aid Kits
- Face Masks
- Hand Sanitizer
- Personal Hygiene Kits (Soap, Toothbrushes, Toothpaste, Floss, Deodorant, Shampoo, Razors and shaving cream)
- Basic Health Supplies (Aspirin, Acetaminophen, Cough medicine, Oximeters, Ace bandages and Compression bandages)

The Dutchess County Departments of Emergency Response and Public Works will assist at collection site operations, including transporting donations to Afya's Yonkers location. Afya is working in partnership with US-Ukraine-Foundation and others to support the Ukrainian medical community and refugees seeking aid.

The Afya Foundation was created to serve as a center for giving back and has become a backbone of goodness for the greater New York community. Afya collects unused medical supplies and equipment from throughout the New York metro area and gives them a second life. These critical materials are shipped to under resourced and compromised health systems all over the globe thereby improving access to healthcare, the quality of care delivered, and the retention of local providers. Since their start in 2007, they have successfully established engagement programs and opportunities for volunteers of all ages, backgrounds, and capacity to build community at home while supporting healthcare abroad.
