**RESOLUTION NO. 07:18:24-1**  
**RE: KINDRED CREEK FARM LETTER OF SUPPORT**

**WHEREAS**, Kindred Creeks Farm, (“KCF”) located at 8 Pleasant Ridge Road, Poughquag, New York 12570, has applied with the New York State Liquor Authority (“SLA”) for a one-day alcohol event permit to serve beer, wine and cider for upcoming events at their business establishment, and

**WHEREAS**, the SLA will consider additional one-day temporary alcohol permits (not to exceed 12 for a calendar six month period) if a letter of no objection is provided by the municipality; and

**WHEREAS**, the Town of Beekman wishes to assist the applicant in expediting the application process and sees no objection to the issuance of future one-day permits;

**NOW, THEREFORE, BE IT RESOLVED**, that to the extent permitted by the SLA, the Beekman Town Board hereby adopts a letter of no objection to be given to the applicant by the Town; and

**BE IT FURTHER RESOLVED** that the Town Clerk is hereby authorized to issue a letter to the applicant and to the New York State Liquor Authority stating the Town has no objection to the issuance of said permits to the applicant by NYSLA.
