**WHEREAS**, the Town Highway Department has historically hired an additional laborer or laborers on a temporary basis to provide snow removal and related services during the winter months; and

**WHEREAS**, the Town Highway Department Employee currently on workers' compensation leave is anticipated to return to duty in November 2025; and

**WHEREAS**, the Town Board finds it likely that additional manpower may be required to efficiently and timely remove snow, plow, treat, and make passable the 137 lane miles of road under the jurisdiction of the Town Highway Department; and

**WHEREAS**, the Town Board, in conformity with, and in the discharge of, its fiscal and budgeting duties and obligations, has determined that the hiring of one (1) temporary laborer is necessary to fulfill this public purpose; and

**WHEREAS**, the Town Board, in conformity with, and in the discharge of, its fiscal and budgeting duties and obligations, has determined that Town funding is available to support the hiring of one (1) additional laborer within the Town Highway Department for the period commencing on October 15, 2025, and concluding on December 31, 2025; and

**WHEREAS**, the Town Board, in conformity with, and in the discharge of, its fiscal and budgeting duties and obligations, has determined that public funds are available from Highway Fund to cover the costs associated with the hiring of one (1) additional laborer within the Town Highway Department for the period commencing on October 15, 2025, and concluding on December 31, 2025; and

**WHEREAS**, the Town Board, in conformity with, and in the discharge of, its fiscal and budgeting duties and obligations, has determined that the hiring of one (1) additional laborer within the Town Highway Department for the period commencing on October 15, 2025, and concluding on December 31, 2025, would be a prudent and constitutional expenditure of municipal funds; and

**WHEREAS**, the Town Board desires to authorize the funding necessary to permit the Town Superintendent of Highways to recruit and hire one (1) additional laborer within the Town Highway Department for the period commencing on October 15, 2025, and concluding on December 31, 2025;

**NOW, THEREFORE, IT IS HEREBY**

**RESOLVED**, that the Town Board hereby authorizes the expenditure of \$24.70 per Hour from the Highway Fund for the purpose of hiring one (1) additional laborer within the Town Highway Department for the period commencing on October 15, 2025, and concluding on December 31, 2025, to assist with the removing snow, plowing, treating, and making passable of the 137 lane miles of road under the jurisdiction of the Town Highway Department; and let it be further
