**RESOLUTION 02:10:26-6****Approving the Full-Time Permanent Hire of Laborer Position for Highway Department**

WHEREAS, the Town Board of the Town of Beekman previously authorized the extension of the duration of a full-time Laborer position within the Highway Department through March 31, 2026, and

WHEREAS, the Highway Superintendent has advised the Town Board that, due to operational, seasonal, and departmental needs, it is necessary to make said position permanent and full-time,

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Beekman hereby authorizes the full-time permanent Laborer position within the Highway Department, and

BE IT FURTHER RESOLVED, that all terms and conditions of permanent full-time employment shall take effect immediately.

WHEREAS, Kindred Creek Farm, ("KCF") located at 8 Pleasant Ridge Road, Poughquag, New York, 12570, has applied with the New York State Liquor Authority ("SLA") for a one-day alcohol event permit to serve beer, wine and cider for upcoming events at their business establishment, and

WHEREAS, the SLA will consider additional one-day temporary alcohol permits (not to exceed 12 for a calendar six month period) if a letter of no objection is provided by the municipality, and

WHEREAS, the Town of Beekman wishes to assist the applicant in expediting the application process and sees no objection to the issuance of future one-day permits,

NOW THEREFORE BE IT RESOLVED, that to the extent permitted by the SLA, the Beekman Town Board hereby adopts a letter of no objection to be given to the applicant by the Town, and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby authorized to issue a letter to the applicant and to the New York State Liquor Authority stating the Town has no objection to the issuance of said permits to the applicant by NYSLA.
